TERMS AND CONDITIONS OF SPONSORSHIP

As a Sponsor you agree to the following terms and conditions:

Sponsors agree to grant to Pan Am Museum Foundation (PAMF) the free, limited, non-exclusive, nontransferable, nonassignable, revocable right and license to use the Sponsor's name and logo provided by the Sponsor solely for the purpose of providing the Sponsorship Acknowledgements, Benefits and otherwise fulfilling its obligations under these Terms and Conditions.

The Sponsor understands that the 2025 Pan Am Museum Gala (the "Event") is being conducted, and Sponsor's Payment will be utilized, in furtherance of PAMF's mission. Sponsor acknowledges that PAMF shall retain full discretion and control over the Event, including planning, scheduling, and operations. PAMF reserves the right to reschedule or cancel the Event for any force majeure event or any other reason it deems necessary or advisable, including without limitation logistical complications, public health concerns, severe weather forecast or other circumstances potentially affecting Event operations, attendance, or success. In such cases, PAMF will make reasonable efforts to provide Sponsorship Acknowledgements and Benefits at a rescheduled or comparable event within a reasonable time with notice to the Sponsor.

The Sponsor agrees that PAMF will have unrestricted use of the sponsorship payment. Any goods or services contributed by Sponsor or promotional activities conducted by Sponsor in connection with Event are provided solely to further PAMF's mission and are without consideration.

PAMF will provide the public recognition and acknowledgement applicable to the Sponsor's support level as set forth in the Sponsorship Commitment Package. Acknowledgement of the Sponsor's sponsorship, while identifying Sponsor, will not endorse Sponsor's products or services or contain any qualitative or comparative language or price information with respect to Sponsor's products or services.

The Sponsor is responsible for consulting with its own tax advisor regarding the deductibility and treatment of its sponsorship payment, including contributed goods, for its own tax purposes. The Sponsor acknowledges that contributed services may not be tax-deductible under this sponsorship and are subject to all applicable IRS tax regulations. Further the Sponsor is solely responsible for all its tax obligations and holds PAMF harmless for its tax obligations related to this sponsorship.

Unless otherwise expressly identified on the Sponsorship Application / Contract, the Sponsor will be a non-exclusive sponsor of the Event and PAMF reserves the right to have other sponsors. Sponsorship Application acceptance will be subject to PAMF's approval. The Sponsor acknowledges that all Sponsorship Acknowledgements and Benefits provided by PAMF relate only to the identified Event, and not similar PAMF events held in other locations.

PAMF will not be held liable for any conduct or issues related to the Sponsor and /or arising from its actions or inactions during the sponsorship period and further the Sponsor agrees to hold PAMF harmless from all liability associated with the Sponsor arising from this sponsorship agreement.
